Last Date: Application form for Entrance examination/exemption must be submitted on or before May 10, 2017 till 3:00 PM. to the Office of Director (Research), University of Kota, Kota.

Details of Admission and Guidelines (as per UGC Notification 2009)

for Ph.D. Program - May 2017

(a) Eligibility

A candidate holding the Master's degree in relevant subject from any recognized University with at least 55% marks is eligible for entrance test for Ph.D. admission (relaxation of 5% for SC/ST and physically handicapped candidates). The student who has qualified an examination conducted by professional bodies leading to CA, CS, ICWA, PGDM approved by AICTE, New Delhi is also eligible for the entrance test. Those candidate who do not have this eligibility will not allow for interview.

(b) Exemption from Entrance Test

1. Those who have qualified UGC/CSIR NET (JRF), ICSSR, ICPR examination/ SET/GATE (with a valid score) / Teacher Research Fellowship holder.
2. A candidate who has passed M.Phil. program through entrance examination and course work as per the UGC notification 2009 from any recognized University.
3. A permanent University/College Teacher who is **appointed by RPSC/duly constituted selection committee**, in case of Teacher from an affiliated college the appointment must be approved by the University.

The candidates belong to category 1 to 3 as above, would be exempted from the Ph.D. entrance test.

Note: Candidates are advised to appear in the subject of their post-graduation only.

***Subject wise number of seats are tentative, these may increase or decrease as per availability of vacant seats.**

(c) Examination Fee and Mode of Payment

Application form (Complete set) for Ph.D. can be downloaded from University website (www.uok.ac.in). The duly filled application form along with the attested mark sheets / documents one copy of the admit card etc. with a crossed D.D. of Rs. 2500/-for general category and Rs1000/- for SC/ST/OBC Non creamy layer and for differently abled (PH) candidates in the name of **Registrar, University of Kota, Kota** payable at **Kota** may be submitted to **Room No. 9, Directorate of Research, Saraswati Bhawan, University of Kota, M.B.S. Road, Near Kabir Circle, Kota** on or before the prescribed last date i.e. – May 10, 2017. If the DD along with documents will reach after the said date i.e. (10-05-2017 up to 3.00PM) the DD and the documents will not be accepted in any case.

(d) Scheme of Test

- Scheme of Paper - The examination will be of two & half hours long. There will be one paper consisting of two part's - first part will have 30 questions of 30 marks & second will have 70 questions of 70 marks. Hence, both the part contains the total 100 question of 100 marks). The qualifying marks for the test is 50% aggregate for both the parts but need to secure 40% marks in each part of the paper i.e. part - I & part - II separately.

* Total Qualifying Marks is 50% out of 100 and 40% in each part of the paper i.e. part - I & part – II separately.			

Note: The syllabus will be the same as that of UGC/CSIR NET examination available on the UGC/CSIR websites.

The test will be only for judging the eligibility of the candidate for Ph.D. programme. **Qualifying of the eligibility test/ entrance will not ensure that the candidate will necessarily to be registered as a Ph.D. student.**

(e) Screening of the application forms

Screening of the application forms will be done after the conduction of the Ph.D. entrance Examination - 2017. Screening of the application form of only those candidate(s) will be done, those who have qualified the Ph.D. entrance test-2017 or exempted from the test i.e. Those who have qualified UGC/CSIR NET (JRF), ICSSR, ICPR examination/ SET/GATE (with a valid score) / Teacher Research Fellowship holder. Screening of the application form for the eligibility will not be done for those candidate(s), who have not qualified the Ph.D entrance test 2017. Also without documents, related to test exemption (NET/GATE/SET Certificate/etc.), the application form will not processed further for the eligibility. If any of the candidates who have qualified the test but he/she are not eligible for the test (during the screening of application forms) then their candidature will not entertained for further process of Ph. D. Admission.

(f) Validity of the Test

The candidate qualifying the test would be eligible to be invited for the interview for the next two years; **such candidates would again submit an application for the exemption from the text along with the relevant certificate, if needed.**

(g) Interview

- (i) The candidates declared qualified in the entrance test and the candidates exempted from entrance test both would be invited for an interview to be conducted by Director (Research). At the time of interview by the expert panel the candidates are expected to discuss their research interest/s. **The candidate would have to produce the original documents at the time of interview.**
- (ii) Only a predetermined number of students shall be admitted to the Ph.D. programme. **The University shall follow the rules of the reservation policy in granting such admissions.**

(g) Allocation of Supervisor / Co-supervisor

The allocation of the supervisor to a selected student shall be done by the Interview Board keeping in view the number of vacant seats available with faculty members, the available specialization among the faculty supervisors, and the research interest of the student as indicated by him/her during the interview. The allotment/allocation of supervisor shall not be left to the individual student or teacher.

(h) Registration and Synopsis Submission through Supervisor

- (i) After allocation of supervisor, all candidates for the degree of Ph.D. shall apply for registration in the prescribed application form obtainable from the University on payment of prescribed fee. Application for Ph.D. registration should accompany outline of the proposed research work along with the theme and methodology to be followed, objectives and importance / relevance of the proposed work, bibliography and other details. The candidate will have to deposit the prescribed registration fee and submit the synopsis to the Director (Research) as per scheduled date.

(ii) The synopsis would be submitted when it is approved by the supervisor. It is to be submitted through the head of the concerned research center.

(i) Meeting of Subject Research Committee

- (i) The candidate applying with synopsis for registration for Ph.D. degree, under the allocated supervisor, will have to defend the proposed work before the DRC/SRC. Improvement, alteration and modifications suggested by the committee in the synopsis have to be incorporated in and the revised synopsis to be submitted within 15 days to the Director (Research).
- (ii) If the outline of the proposed research work is approved, the Director (Research) shall notify the candidate concerned regarding approval of outline of work and ask him/her to take admission in the institution where he/she plans to work. The candidate shall intimate the date of his/her joining the research to the Director (Research) through the supervisor and Head of the concerned research center/institute. **The date of registration would be the date of admission at this stage.**
- (iii) The candidate will be required to submit, through proper channel, his admission report to the University positively within one month of the date of the issue of registration letter.

(j) Course Work

After having been admitted to the Ph.D. programme, each student shall be required to undertake course work for a minimum period of one semester. The course work shall be treated as pre-Ph.D. preparation. It shall include two papers, one shall be on research methodology which shall include quantitative methods and computer applications. The other one shall be an intensive review of available literature/research techniques relating to the proposed research area of the Ph.D. scholar. Candidates undergoing course work are required to obtain a certificate from his/her supervisor with counter-signed by the head of the concerned institution to the effect that he/she has successfully completed the course work. **The mode of examination regarding course work would be decided by the concern department and the supervisor.** The course work will be offered on self- sufficiency basis to the Ph.D. scholars. If found necessary, the courses may be carried out by doctoral candidates in sister departments / institutes either within or outside the university for which due credit will be given to them.

(k) Exemption from Course Work

The Candidates who have already done course work as per UGC notification 2009 in the concerned subject from any recognized university may be exempted from course work (relevant certificate is required).

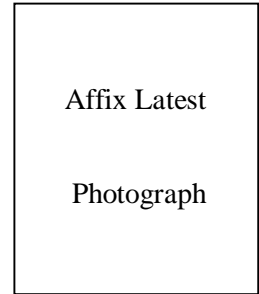

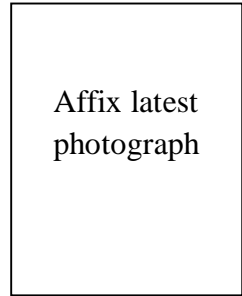

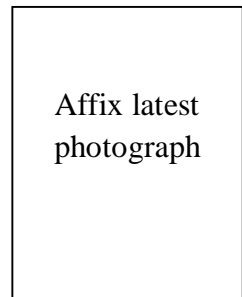
