- The interested bidders may submit their online bids along with separate Demand Drafts drawn in favour of "Registrar, University of Kota, Kota" payable at Kota towards the cost of Tender Fee (Non-refundable) and RISL Processing Fee (Non-refundable) demand draft shall be in favour of "Managing Director, RISL" payable at Jaipur. A separate Demand Draft of Bid Security (Refundable) shall be in favour of "Registrar, University of Kota, Kota".
- The above demand drafts must reach physically in the office of the Procurement Entity, University of Kota, Kota on or before the last date as mentioned above failing which bids shall not be considered.
- Bidders, having digital signature certificate (DSC) as per the IT Act, 2000 to sign their electronic bids, shall submit their offers online on the www.eproc.rajasthan.gov.in within stipulated time and date mentioned herein above. Bids shall not be accepted personally. The bids will be opened on the same date and time before purchase committee in the presence of bidders or their authorized representatives who may be present.
- In the event of the specified dates being a holiday, the activities assigned on that date may be carried out on the next working day on the same time.
- University of Kota, Kota is not bound to accept the lowest bid and may reject whole bid or any part of the bid without assigning any reason therefore.
- Bids received after the prescribed time and date will not be considered.
- The bidders shall have to submit GST registration number without which the bids will not be considered.
