

The Interested bidders may submit their on-line bids along with separate Demand Drafts drawn in favour of "Registrar, University of Kota, Kota" payable at Kota towards the cost of Tender Fee (non-refundable) and RISL Processing Fee (Non-refundable) demand draft shall be in favour of "Managing Director, RISL" payable at Jaipur. A separate Demand Draft of Bid Security/earnest money (Refundable) shall be in favour of Registrar, University of Kota, Kota.

The above original demand drafts and original Affidavit on Non Judicial stamp paper of Rs. 100/-, regarding trueness of facts / information provided in for tender must reach physically in the office of Procurement Entity, University of Kota, Kota on or before last date as mentioned above failing which bids shall not be considered.

The technical Bids will be opened on the same date and time before tender committee in the presence of bidder or their authorized representative who wish to be present.
